





That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 10th day of May, 1966, I found the Quarter corner of Sections 15-16 which was evidenced by remains of the G.L.O. resurvey of 1933 a set 3 foot long 1 inch diameter iron post with brass cap marked

Oak 6 inch S22 $\frac{1}{4}$ °E 57 links - Now a 10 inch Oak S22°E 37.3 feet.

S16 S15

Oak 7 inch N17 $\frac{1}{2}$ °W 55 links - Now a 10 inch Oak N17°W 36.3 feet.
