




 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
 I further depose and say that on the 2nd day of May, 1966, I found the Center South 1/16 corner of Section 13 which was evidenced by survey by G.L.O. in 1933 iron post 3 feet long 1 inch in diameter with brass cap marked
