 That I reside at Bemidji , Minnesota , and am registered as a Land Surveyor under the
 laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807
 I further depose and say that on the 10th day of August , 19 64 ,
 I found the North 1/16 corner of Sections 22 - 23
 which was evidenced by the remains of the G.L.O. resurvey of 1926.
 Brass cap had been pulled up, and leaning against S-E Bearing tree.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker
 consisting of the G.L.O. brass cap which was still in good condition set it in East wheel
 track in old logging road 0.2 feet below surface of ground, set from remains of
 original B.T.'s.
