





That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 6th day of May, 1966, I found the Quarter corner of Sections 14-23 which was evidenced by G.L.O. resurvey in 1933 a set iron post 3 feet by 1 inch in diameter with brass cap marked

Jack Pine stump N3°W 187 lks

Norway Pine 12 inch N48½°W 331 lks or 218.46 feet - Now a 19 inch N48°W 218.46 feet - scribe visible.

White Pine 14 inch S64½°W 287 lks or 189.42 feet - Now a 27 inch S64°W 189.42 feet - scribe overgrown.
