That I reside at \_\_\_\_\_, \_\_\_\_\_, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 29th day of July, 1964, I found the East 1/16 corner of Sections 14 - 23 which was evidenced by an iron post 3' long 1" diameter with Brass cap marked:

E 1/16  $\frac{S 14}{S 23}$   
 1933

Norway Pine 6" S43 $\frac{1}{2}$ °E, 24 links or 15.84' (now a 15" Red pine S43 $\frac{1}{2}$ °E, 15.8' scribe overgrown)

Jack Pine 10" N15°W, 10 links or 6.60' (now a 14" Jack pine N15°W 6.0' scribing visible)

The iron post and bearing trees were set by G.L.O. resurvey of 1933, and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marker was set, used G.L.O. brass cap as corner.
