That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 2nd day of May, 1966, I found the Section corner of Sections 13-14-23-24

which was evidenced by a cylindrical concrete monument 2 feet long 6 inches in diameter with brass cap stamped.

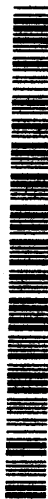
