Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 5<sup>th</sup> day of October, 1961, I found the Section corner of Sections 18-19-13-24 which was evidenced by a cylindrical concrete monument 2 feet long 5 inches diameter with brass cap marked:

Spruce. 5 inches S233/4°W 49lks or 32.34 feet (Now a Balsam wind fall with scribe visible S23°W 32.34)	T145N
