That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

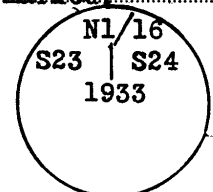
I further depose and say that on the 26<sup>th</sup> day of July, 1961, I found the North 1/16 corner of Sections 23-24

which was evidenced by an iron post 3 feet long 1 inch diameter with brass cap marked:

Poplar 5 inch N59 3/4° E 34 lks or 22.44 feet (Now 8 inch Aspen N60° E 22.4 feet scribe visible)

Norway Pine 20 inch S63 1/4° W 91 lks or 60.06 feet (Now a 28 inch pine S63° W 60.0 feet scribed N1/16 S23 visible)

The iron post and bearing trees were set by G.L.O. Resurvey of 1933.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No. new marker set, used G.L.O. brass cap as corner.
