





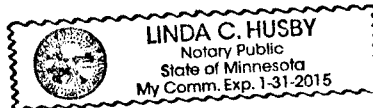

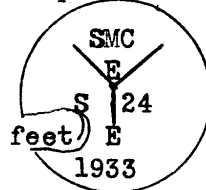

That I reside at Cass Lake ....., Minn. ...., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.....  
I further depose and say that on the 15<sup>th</sup> day of January ....., 19 62., I found the Special Meander corner of Section 24 which was evidenced by an iron post 3 feet long 1 inch diameter with brass cap marked:

Cedar. 12 inch S30 $\frac{1}{4}$ <sup>0</sup> E 41 lks or 27.06 feet (Now a dead cedar 13 inch marked S24SMC)  
Elm. 9 inch S47 $\frac{1}{2}$ <sup>0</sup> W 34 lks or 22.44 feet (Now a 13 inch Elm S49<sup>0</sup> W 22.44 feet)



The iron post and bearing trees were set by G.L.O. Resurvey of 1933.  
A copy of the survey notes are on file in the State Capitol, St. Paul, Minn.  
and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new marker was set, used G.L.O. brass cap as corner.
