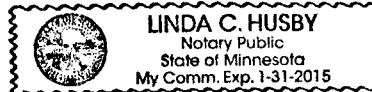

I further depose and say that on the 16th day of May, 1966, I found the Center West 1/16 corner of Section 24 which was evidenced by G.L.O. survey of 1933 a set iron post 3 feet long by 1 inch in diameter with brass cap marked
