That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 16th day of May, 1962, I found the quarter corner of 24 - 19 which was evidenced by remains of G.L.O. resurvey of 1933.

N. Pine 6" S.88°E. 49 links (32.34') (now a 11" R. Pine S. 84°E. 32.34' scribed 1/4 S.19 B.T.)
