That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 17th day of May, 1966, I found the Quarter corner of Sections 21-28 which was evidenced by G.L.O. resurvey of 1933 a set brass cap 3½ inches in diameter with 3 inch stem in concrete monument 2 feet long by 5 inches in diameter marked

Red Oak 10 inch N62°E 22 lks marked 1/4 S21 BT - Now a stump at record bearing and distance - scribe visible.
