Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minn., and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 31st day of January, 1962, I found the South 1/16 corner of Sections 25-30

which was evidenced by an iron post 3 feet long 1 inch diameter with brass cap marked, Cedar 10 inch S18¹⁰E 35 lks or 23.10 feet (Now a cedar stub. S19⁰E 23.1 feet scribe decayed)

Cedar 8 inch S58 3/4⁰W 46 lks or 30.36 feet (Now a 10 inch cedar scribed "S 1/16 S25" S59⁰W 30.36 feet)

The iron post and bearing trees were set by G.L.O. Resurvey of 1933.

A copy of the survey notes are on file in the State Capitol, St. Paul, Minn.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new marker set, used G.L.O. brass cap as corner.
