That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 12th day of May, 1966, I found the Quarter corner of Sections 30-31 which was evidenced by an iron post 3 feet long by 2 inches in diameter, in place of concrete monument, with brass cap marked
