







That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 16th day of May, 1966, I found the Quarter corner of Sections 28-33 which was evidenced by G.L.O. resurvey of 1933

a set 5 inch diameter cylindrical concrete monument with brass cap marked 1/4 S28 S33  
 White Pine 15 inch N2 1/2° E 78 lks or 51.48 feet - Now a 21 inch N3° E 51.48 feet - scribe overgrown. 1933

White Pine 15 inch S8 1/4° E 55 lks or 36.30 feet - Now a 25 inch S8° E 36.3 feet - scribe overgrown.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new marker set, used G.L.O. brass cap.
