Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
 I further depose and say that on the 11th day of October, 1958, I found the 1/4 corner of Sections 12-13 which was evidenced by one remaining original scribed bearing tree of the Government survey of 1874.

(a) Six inch Jack Pine (now 10 inch stump partely decayed with scribing B.T. visible) N 54° E 100 links or 66 feet.

I checked and found no evidence of original government corner or other original government bearing tree.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2 inch inside diameter 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze stamped tablet:
