AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:
That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
I further depose and say that on the 5th day of November, 1958, I found the Meander corner of sections 14-23 which was evidenced by one remaining original scribed bearing tree of the Government Survey of 1873.

A 10 inch Red Pine (now 27 inch with scribing B. visible) N. 62° E., 34 links or 22.4 feet.

I checked and found no evidence of the original Government corner or other original Government bearing tree.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:
