Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 31 day of January, 1962, I found the Meander corner of Sections 36-31 which was evidenced by an iron post three feet long one inch diameter with brass cap marked :

White Birch 8 inches S45°E 30lks or 19.8 feet (Now a 10 inch Birch S46°E 19.8 feet scribe overgrown.)
