





, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 23rd day of December, 1964, I found the Section corner of Sections 5-6-31-32 which was evidenced by a concrete monument set by G.L.O. resurvey in 1934 with a 3 1/2" diameter brass tablet stamped:

Jack pine 7" S17°E 11 links (scribed T115N R29W S 5 BT)
(now a stump scribed B.T. at record bearing and distance)T116N R29W
S 31 | S 32
