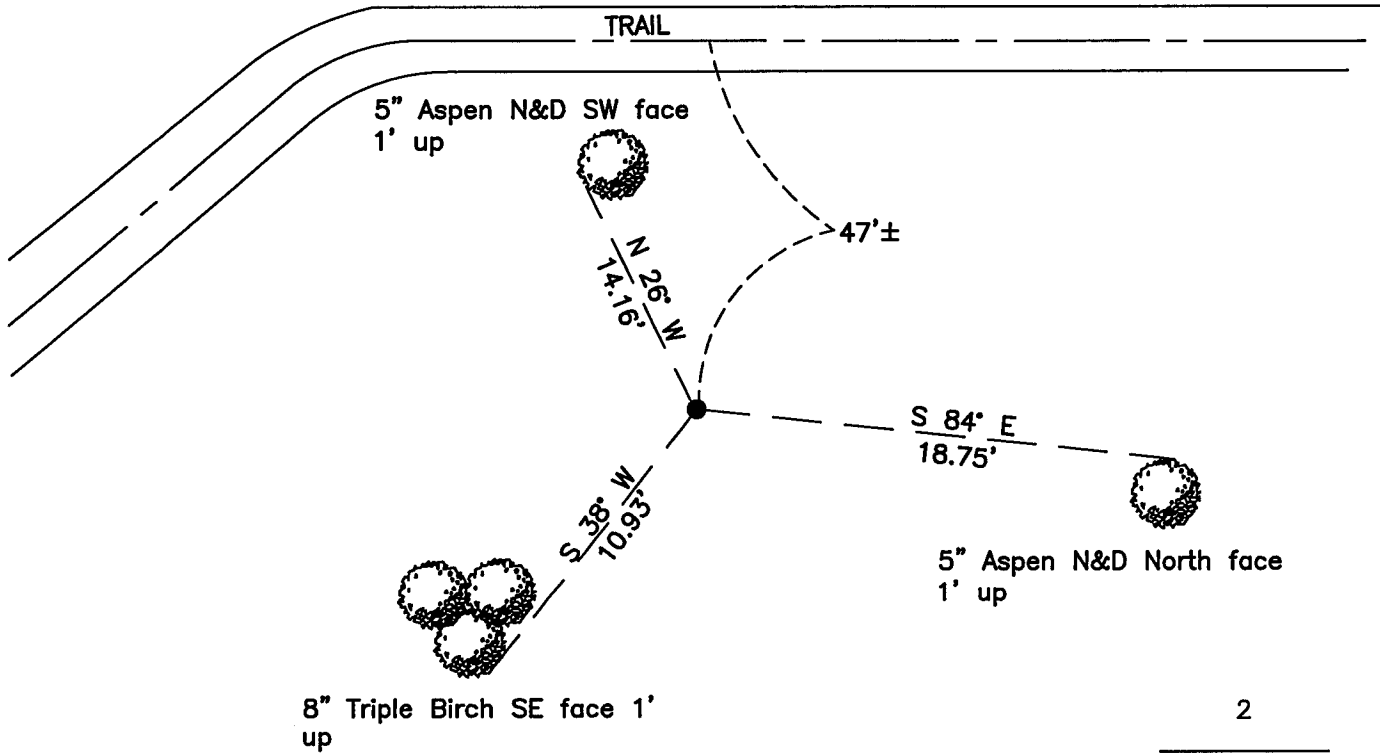

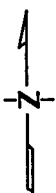

Statement of Evidence**North Quarter corner of Section 11, Township 138 North, Range 31 West, 5th Principal Meridian.**

- Nov. 1870 T.B.Walker, General Land Office (GLO) Deputy Surveyor set a post for the original corner and referenced it as follows:
16" W. Pine S 03° W 40 links
6" Linden N 33° 30' E 28 links
Said records are on file at the Minnesota Historical Society, St. Paul, Minnesota, copies are filed with the Cass County Surveyor's Office (CCSO).
- May 1915 J.W. Curo, Cass County Surveyor, LS 1428, County Surveyor, County Resurvey, on file at the Cass County Records Office, in cabinet E, sheet 47 indicates a 2 1/4"X4' Iron Monument was set.
- Nov. 1919 J.W. Curo, LS 1428, Book 26, Page 25, Curo commences cutting a line south at said corner.
- Oct. 2012 A KLJ survey crew found a 2" capped Iron Pipe, and is witnessed with the ties shown on the front of this certificate. Jarrett Leas, RLS #42619, after analysis of record and survey information accepts this monument as the correct perpetuation of the corner.
