Statement of Evidence

North Quarter corner Section 31, Township 140 North, Range 31 West, 5th Principal Meridian.

Nov. T.B. Walker, General Land Office (GLO) Deputy Surveyor, in the notes of the subdivision of Township 140 North, Range 31 West, set a post for the original corner and referenced said post as follows:

12" Sp. Pine N 85 1/2° W 117 links (77.22 feet) 10" Sp. Pine S 71° W 152 links (100.32 feet) The above record is on file with the Minnesota Historical Society in St. Paul, Minnesota, copies are filed with the Cass County Highway Department, Surveyor's Office (CCHD/SO).

July Hiram Township Supervisor's Road Order, on file at the Cass County Highway Department (CCHD), description and pictorial indicate a road from the southwest corner of Section 30 easterly to the southwest corner of Section

May
B. Hippen, technician and P. Swentkofske, CCHD backhoe operator, records of the CCHD/SO, dug a 10 foot by
60 foot hole 3 feet deep centered 2 feet south of centerline of County Road Number 41, previous road work had

cut into natural ground to the north. Found a ring of ash with small pieces of charred wood, down 2.5 feet.

Nov. B.W. Skipton, LS 17768, Certificate of Survey, copy on file in the CCHD/SO, accepted the ash ring and charred wood as evidence of the original corner and set a 1/2 inch by 14 inch iron pipe with plastic cap marked RLS

#17768.

Aug. B. Hippen, technician, records of the CCHD/SO, found 7/8 inch outside diameter iron pipe capped RLS 17768, down 0.5 foot, 3 feet, more or less, south of the centerline of CSAH #41 and witnessed it as follows:

6" J. Pine N 30° W 42.52 feet 9" J. Pine N 57° E 69.36 feet

10" Burr Oak S 48° W 74.41 feet

25, "following section line as near as practicable".

The recovered and established witnesses for this corner position are shown on the face of this document.

Analysis of the recovered record data, field evidence and survey measurements, indicates that the monument recovered in 2010 by the CCHD/SO, is the correct perpetuation of this corner.
