May H.D. Craig, U. S. Surveyor, in the notes of the Dependent Resurvey of a portion of Township 144 North,

1931 Range 31 West, Set an iron post, 3 ft. long, 1 in. diam., 30 ins. in the ground, for the center N. 1/16 sec. cor. of sec. 20 with brass cap" and referenced it as follows:

Oct. B. Hippen, technician, records of the CCHD/SO, found a 1 inch outside diameter iron pipe with GLO Brass cap,

2008 up 1.6 feet, at edge of low ground and 1931 witnesses as follows:
