## Statement of Evidence

North Quarter corner of Section 25, Township 136 North, Range 31 West, 5th Principal Meridian.

R. Cronk, General Land Office (GLO) Deputy Surveyor in the notes of the subdivision of Township136 North, Aug.

Range 31 West, set a post for the original corner and referenced it as follows: 1870

S 10° E 17 links (11.22 feet) 12" Aspen N 20° E Said records are on file with the Minnesota Historical Society, St. Paul, Minnesota, copies are filed with the Cass

County Highway Department, Surveyor's Office (CCHD/SO).

W.H. Hallett, Surveyors Report, Certificate image 5249, on file in the CCHD/SO, road survey indicates the Oct.

1903 subject corner position in a road.

A.W. Moulster, LS 967, Survey Record #191, Book A, page 463 and Survey Record #277, Book B, page 167 and Oct. 1911 Curo Book 50-1, pages 123, 125 and 126,132 and 135, on file in the CCHD/SO, lists GLO witnesses and states "No trace of ¼ cor." Page 125 states John Nelson testifies "That Hallet established the ¼ cor – bet 24 & 25 – and that he found no BTs." Page 126 he states "At 1/4 cor. bet 24-25 - I found the stone set by Nelson - which he put where Hallets Stake was. I find 2 old rotten stumps." As follows:

10 feet S 3° E Pop N 34° W "This does not correspond with the Gov. field notes. As Nelson was chaining when Hallet surveyed and this is his SW Cor – and he says he does not remember ever seeing any BT's here – Hallet evidently did not have any BT's.

Power Pole

I ignore Hallets 1/4 cor.'

March D. Cole, LS 1286, Cass County Highway Department (CCHD), S.A.P. 11-624-01, on file in the CCHD, Plan indicates corner at Station 154+70.6, at intersection with fence line to North and 6 feet West of the centerline P.I. 1967

B. Hippen, technician, records of the CCHD/SO, set an aluminum Cass County monument at the 1967 distance June 2017 to the fence line on the line between the northeast and northwest corners of Section 25, 8 feet, more or less, south of the new centerline of CSAH #24 and witnessed as follows:

8" N. Pine N 28° W 96.01 feet 6" W. Pine S 14° W 67.58 feet

The monument, recovered and established references for the position are shown on the face of this document.

Analysis of the recovered record data, field evidence and survey measurements, indicates that the monument set by the CCHD/SO in 2017 is the accepted location of this corner.
