

Statement of Evidence

**East Quarter corner, Section 32, Township 139 North, Range 26
West, 5th Principal Meridian, Cass County, Minnesota**

1863 – Johnson and Thornton, US Deputy Surveyors originally established this corner position while surveying the interior subdivision lines of Township 139 North, Range 26 West. A wood post was set to mark the corner position with the following witnesses:

14" W. Pine S 50° E 57 links
20" W. Pine N 64° W 14 links

Information on file in the MN Historical Society, St. Paul, MN. Copies on file in the Cass County Highway Department/Surveyors Office (CCHD/SO).

2018 –A Stonemark survey crew found a bent cast aluminum monument stamped 11946, measured the cast aluminum monument at plumb position, and is witnessed with the ties shown on the front of this certificate. Found a 2" iron pipe next to the cast aluminum monument, and disregarded it. Patrick Trottier PLS #41002, after analysis of record and survey information accepts this monument as the correct perpetuation of the corner.
