## Northeast Corner Section 22, Township 136 North, Range 31 West

The Department of Natural Resources, Division of Lands and Minerals, contacted the following offices for information regarding this corner:

Land Surveyor Ross Wamre, Survey Mapping Solutions, Inc.

1870 The US General Land Office field notes, on file in the Minnesota Historical Society, as surveyed by Richard Cronk, show this corner to be marked with a post and the following bearing trees were marked:

7" Tamarack	N 66 E	3 links	1.98'
7" Tamarack	S 32 W	4 links	2.64'
9" Tamarack	N 27 W	13 links	8.58'
8" Tamarack	S 44 ½ E	12 links	7.92'

1912 Information on file in the Cass County Highway Department Surveyors Office. In September, Cass County Survey Record No. 240 in Book B, page 16, field notes for a large survey in the township, state they traversed beginning at the northwest corner of Section 22 and to this corner. They found the old Government stake rotted and found the southeast bearing tree and found the rotted stumps of the other bearing trees. They set a 6 X 6 X 40 inch tamarack post and tack for the true corner.

- 1913 Information on file in the Cass County Highway Department Surveyors Office. In October, the survey crew pulled up the tamarack post and set a 2 1/2 X 48 inch galvanized iron pipe with anchor rod through the bottom full length in the ground in a bed of concrete for the true corner.
- 2019 In October, the Department of Natural Resources survey crew found a 2 1/2 iron pipe filled with concrete and nail in center +/- 65 feet east of clearing and T-post fence line. The survey did not find any GLO bearing trees or 1913 bearing trees. No other occupation was found. This iron pipe was accepted as the best available evidence of the corner location.
