2021 Crews at Kramer Leas Deleo searched for original corner evidence and bearing accessories and found nothing. Local land owner, Wade Huotari, states that the occupation of the east-west road intersection with field edge occupations bearing south and north has been evident for over 40 years. The corner location is considered obliterated. A ½" x 30" iron pipe with plastic cap stamped "KRAMER 23668" was wet on centerline of old road grade bearing East-West, at the intersection of old occupations lines bearing north and south. It was determined this location as best available evidence of the original corner location. The following bearing ties were set.
