CENTER OF SECTION 1, TOWNSHIP 139 NORTH, RANGE 28 WEST, CASS COUNTY, MINNESOTA

- 1920 County Surveyor, James H. Flynn under a contract dated June 4, 1918 and Deputy County Surveyor, Ben F. Clark, under his contract dated May 26, 1919 set a monument at the center of Section 1. (Plat No. 1 in T 139 N, R28 W, 5th P.M. Doc. 69793, recorded March 3, 1922)
- A Cass County survey crew recovered a 1-1/2 inch diameter iron pipe protruding 2.5 feet above the ground. This pipe was accepted as the one set in 1921 by the County Surveyor. As the monument was witnessed by local land owners, it is accepted as the physical location of the corner.
