ROAD PÉTITION

To the Supervisors of the Town of May in the County of Cass and State of Minnesota:

The undersigned, legal voters who own real estate, or who occupy real estate under the Homestead or Pre-emption Laws of the United States or under contract from the State of Minnesota, within two miles

of the road to be laid out hereby petition you to lay out, have surveyed and establish a road at the Southwest corner of lot ten of Section Seven of Township One Hundred thirty three, Range Thirty One, thence running ~~###~~ east, on the line between lots ten and twelve, and nine and thirteen, and between the South half of the Southeast Quarter and the North half of the Southeast quarter, all in section Seven of said township, thence on east on the line between the Southone half of the South one half and the North one half of the South one half of Section eight in said town to the section line between sections eight and nine of said said township.

Then beginning at the Northwest corner of the forty acres of land described as the Southeast quarter of the Southeast quarter of Section Seven, Township One Hundred Thirty three and Range Thirty One and running North on the Section line between Sections Seven and eighteen to the Northwest corner of the said section eight in said township
