Within five days after date of within order Town Board shall make its Award of Damages and file all papers pertaining to the road with the Town Clerk.
The Town Clerk must not record this order within thirty days after filing, and not there, if an appeal has been taken, until the order is confirmed on appeal. But if no appeal is taken, or if on appeal this order is confirmed, it, together with the award, must be recorded and then transmitted to the County Auditor, to be filed and preserved by him.

State of Minnesota, County of Cass Town of Walden SS:

Whereas, Upon the petition of 10 - Tom legal voters who own real estate or who occupy real estate under the homestead or pre-emption laws of the United States or under contract from the State of Minnesota, within three (3) miles of the road proposed in said petition to be laid out; which said petition was filed with the Town Clerk, who forthwith presented it to us for action thereon, and which said proposed new Road is set forth and described in said petition as follows, viz: Begining Run the South River Road

on the section line between sections 10 and 11, or at the south west corner of N W 1/4 of N W 1/4 section 11 - 137 - 30. Thence going North for about 80 eighty rods or to the southeast corner of south west quarter of sections 2. Town 137, Range 30 where it terminates.

And Whereas, Upon receiving said petition, we did, within thirty days thereafter, make out an order or notice of hearing and fix therein a time and place at which we would meet and act upon said petition, to-wit: On the 15th day of August 1916, at the residence of Mr. Hargrave, or what is known as the sunny side schoolhouse

causing copies of such notice to be posted in three public places in said town, at least ten days before such meeting; and having met at such time and place as above named in said notice, and being satisfied that the petitioners had, at least ten days previous to said time caused said notice of time and place of hearing to be given to all the occupants of the land through which such road might pass, by serving the same personally upon each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such roads, and heard all persons interested, and any and all reasons for or against the laying out and establishing the same, and being of opinion that such new Road was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to establish said road, and caused a survey thereof to be made according to the report and plat herewith

accompanying, the description of which as so is as follows, to-wit: Beginning Run the South River Road on the section line between sections 10 and 11, or at the south west corner of N W 1/4 of N W 1/4 section 11 - 137 - 30. Thence going North for about 80 eighty rods or to the southeast corner of south west quarter of sections 2 Town 137 Range 30 where it terminates.

It is Therefore Ordered and Determined, That a road be, and the same is hereby allowed and established according to the description last aforesaid, and the report and plat herewith accompanying which is hereby made a part of this Order, and it is declared to be a public road Town rods wide, the said description above given being the center of said road. IS HEREBY GIVEN, That the Supervisors of the Town of Walden in the County of Cass and State of Minnesota, will meet on the 15th day of April 1916, at 11 o'clock in the forenoon, at the residence of O. H. Haugen in said Town, for the purpose of personally examining the route named below, proposed for a new road, and for hearing all reasons for or against said proposed new road and to act upon said petition. Said proposed new road as described in the petition, is as follows:

On the South River road near what is known as the Sunnyside Schoolhouse, between sections 10 and 11—Town 137, Range 30, thence going due North on section line between sections 10 and 11— to the section corners 2-3-10 and 11— or about 80 rods, where it terminate

State of Minnesota, County of Cass Town of Walden SS:

Whereas, A road was laid out and established on the 15th day of April 1914, by us, the Supervisors of the said Town of Walden on the petition of Sam legal voters who own real estate or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within three (3) miles of said road, which said road

is set forth and described in the foregoing Supervisors' Order, made by us, and Whereas, A part of the damages sustained by reason of the laying out said road has been ascertained by the agreement of the owners of the lands through which said road passes, with us, and a part of the owners of the said lands have in writing released all claims to damages; but not being able to agree with the owners of the following described lands, claiming damages by reason of said road passing through, and the owners of some of the said lands being unknown, we have assessed the damages to each of such individual claimants with whom we could not agree, and awarded damages to the owners of such lands through which such road passes as are unknown, at what we deemed just and right; taking into account and estimating the benefits the road will confer on the claimants and owners, as well as the disadvantages. We have assessed and awarded damages as follows:
