The Town Clerk must not record this order within thirty days after filing, and not then if an appeal has been taken, until the order is confirmed on appeal. But if no appeal is taken, or if on appeal this order is confirmed, it together with the award, must be recorded and then transmitted to the County Auditor, to be filed and preserved by him.

State of Minnesota, County of Cass Town of Ansel SS:

Whereas, Upon the petition of more than eight legal voters who own real estate or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within three (3) miles of the road proposed in said petition to be established; which said petition was filed with the Town Clerk, who forthwith presented it to us for action thereon, and which said proposed road is set forth and described in said petition as follows, viz: Beginning at the SW corner of Section Thirty-three (33) in said township, thence east along the section line to the SE corner of Section Thirty-six (36)

And Whereas, Upon receiving said petition, we did, within thirty days thereafter, make out an order or notice of hearing and fix therein a time and place at which we would meet and act upon said petition, to-wit: On the 31st day of December 1915, at 1:30 o'clock in the afternoon at Creek Post Office on Sec. 20, in said town in conjunction with town board of town of Poplar

causing copies of such notice to be posted in three public places in said town, at least ten days before such meeting; and having met at such time and place as above named in said notice, and being satisfied that the petitioners had, at least ten days previous to said time caused said notice of time and place of hearing to be given to all the occupants of the land through which such road might pass, by serving the same personally upon each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such roads, and heard all persons interested, and any and all reasons for or against the establishing of the same, and being of opinion that such road was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to establish said road, and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so established is as follows, to-wit: Beginning at the SW corner of Section Thirty-three (33) in said township, thence east along the section line to the SE corner of Section Thirty-six (36).

And whereas, said road is wholly on a section line already surveyed we deemed a survey of said road unnecessary.

And Whereas, said town boards, acting in conjunction, decided that the following is a just and proper provision of said road to be constructed and maintained by said towns of Poplar and Ansel respectively, to-wit:
~~TOWN OF ANSEL commencing at the corner of Sec. in said town of Ansel, thence East along the section line to the adjacent to Section 34 and of section 36 in said town of Ansel~~

It is Therefore Ordered and Determined, That a road be, and the same is hereby allowed and established according to the description last aforesaid, and the report and plat herewith accompanying which is hereby made a part of this Order, and it is declared to be a public road 100 ft rods wide, the said description above given being the center of said road.
