Whereas, upon the petition of six free-holders and legal voters of said town, to establish and lay out a cartway two rods wide, which said petition was filed with the town clerk, who forthwith presented it to us for action thereon and which said proposed cartway is set forth and described in said petition as follows:

Beginning at the west end of the road in the plat of Green Shores No. 11 in Government Lot 2 in section 56, Town 141, Range 31; thence westerly into Government Lot No. 1 in same section 25 in said town and range last named to connect up with State Highway No. 19, said cartway following as closely as possible the trail now followed over said course.

AND WHEREAS, Upon receiving said petition, we did, within thirty days thereafter, make out an order or notice of hearing and fix therein a time and place at which we would meet and act upon said petition, to-wit: On the 17th. day of April, 1926, at 2 o'clock P. M. at the intersection of the proposed cartway and State Highway No. 19, causing copies of such notice to be posted in three public places in said town, at least ten days before such meeting; and having met at such time and place as above named in said notice, and being satisfied that the petitioners had, at least ten days previous to said time caused said notice of time and place of hearing to be given to all the occupants of the land through which such road might pass, by serving the same personally upon each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such road, and heard all persons interested, and any and all reasons for or against the establishing and laying out of the same, and being of opinion that such cartway was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to establish and lay out said cartway, and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so established and laid is as follows, to-wit:

AS above set forth, and following through the land of J. W. Goble, to-wit: Lot 2, Sec. 36-141-51 not included in the plat of Green Shores No II, the route marked out and blazed by said J. W. Goble at the time of said hearing.

IT IS THEREFORE ORDERED AND DETERMINED, that a cartway be, and the same is hereby established and laid out according to the description last aforesaid, and the report and plat herewith accompanying which is hereby made a part of this order, and it is declared to be a public cartway two rods wide, the said description above given being the center of said road.

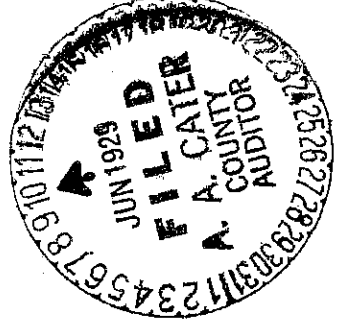
