# Supervisors Road Order.

State of Minnesota }  
County of Cass }  
Town of Gould. }

Whereas, upon the petition of (eight) legal voters, who own real estate, or who occupy real estate under the homestead or pre-emption laws of the United States or under contract from the State of Minnesota within three miles of the road proposed in said petition to be laid out; which said petition was filed with the town clerk, who forthwith presented it to us for action there on, and which proposed new road is set forth and described in said petition as follows, Beginning at the quarter line of section three (3) in Township 143 Range 28 and Section Thirty four (34) in Township 144 Range 28 at a point between said Township 143 Range 28 and Township 144, Range 28, and same point being on the north side of section three (3) at the point where said quarter line intersects said township line, and extending south one mile along said quarter line as near as practicable to intersect the County Road on the south line of section three (3), same Town and Range, following thence east along said County road to the north east corner of section<sup>10</sup> Township

3 Range 28, one half mile, thence following said County road South one mile to the North east corner of Section Fifteen, Township 143 Range 28: establishing a road thence South <sup>one mile</sup> on the section line between sections 14 and 15, ~~and sections 22 and 23, and sections 26 and 27 and sections 34 and 35 all in Township 143 Range 28 to a point where this section line intersects the south line of Township 143 Range 28~~

And whereas, upon receiving said petition, we did, within thirty days thereafter, make out an order or notice of hearing and fix therein a time and place at which we would meet and act upon such petition, to-wit: On the 23 day of Feb. A.D. 1916, at the office of the Town Clerk, causing copies of such notice to be posted in three public places in said town, at least ten days before such meeting, and having met at such time and place as above named in said notice, and being satisfied that the petitioners had, at least ten days previous to said time, caused said notice of time and place of hearing to be given to all the occupants of the land through which such highway might pass, by serving the same personally upon each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such highway and heard any and all reasons for or against the laying out the same, and being of the opinion that such laying out was necessary and proper, and that the public interest

ld be promoted thereby, we granted the prayer of  
aid petitioners and determined to lay out said road.  
This road was ordered established according to the  
petition to a point as follows to the Southeast cor-  
ner of Section 15 town 143 R 28: Balance deemed  
impractical.
