

**DIRECTIONS TO ASSESSORS.**

Office of County Auditor.

*Wagon* County, Minn., *June 1st* 1873  
 to *Geo. W. Nichols* Assessor of the *second*  
*Assessor District* in the County aforesaid.

In conformity to the requirements of law, I herewith deliver to you the assessment roll for the year 1873, containing all lands, city and town lots within the said *second*

*Assessor District* which have become subject to taxation since the last assessment, so far as the same have come to my knowledge, from any source. And I hereby direct you to assess the same and make returns thereof to the Clerk of your Town on or before the second Monday in July of this year, as required by law, and add thereto any lands, city or town lots which you may find subject to taxation, which have been omitted from this roll and not previously assessed.

You will also set forth each tract or lot of real property on which any building or structure of any kind, worth more than one hundred dollars, has been erected since the last assessment; the kind of structure and the value thereby added to such real property; and in case of damage by fire, flood or otherwise, of over one hundred dollars in such structures, you will state, as near as practicable, how much less such real property is worth in consequence of such destruction; and make returns to the Clerk of your Town, as provided in section 24 of chapter 21 of the General Statutes, as amended.

And you are hereby also directed to ascertain the proportion of the value of all tracts of land, city and town lots described within as being transferred by us, agreeably to section 28 of chapter 21 of the General Statutes.

You are also directed to make out the assessment of all personal property, moneys, credits, investments in bonds, stocks, joint stock companies, or otherwise, in your town, and make returns thereof as required by law.

Your attention is called to an act approved February 25th, 1873, entitled "An act to compel Assessors to assess all personal property which is not exempt by law."

A form of return to be signed by you may be found in this book.
