Will you please compare the last description in the list with the corresponding ones in the receipt. There appears to be a difference in the number of the section. I may be to blame for the misleading description, but the number of the section is right, 34.

The company owns no acreage in the SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of Sec. 26, and not quite an acre for road and alley use in the NE $\frac{1}{4}$  of NE $\frac{1}{4}$  of Sec. 34. Cass County appropriated the Federal Dam Road that passes through the company's land several years ago.

The rough sketch may help you out in making the proper corrections.

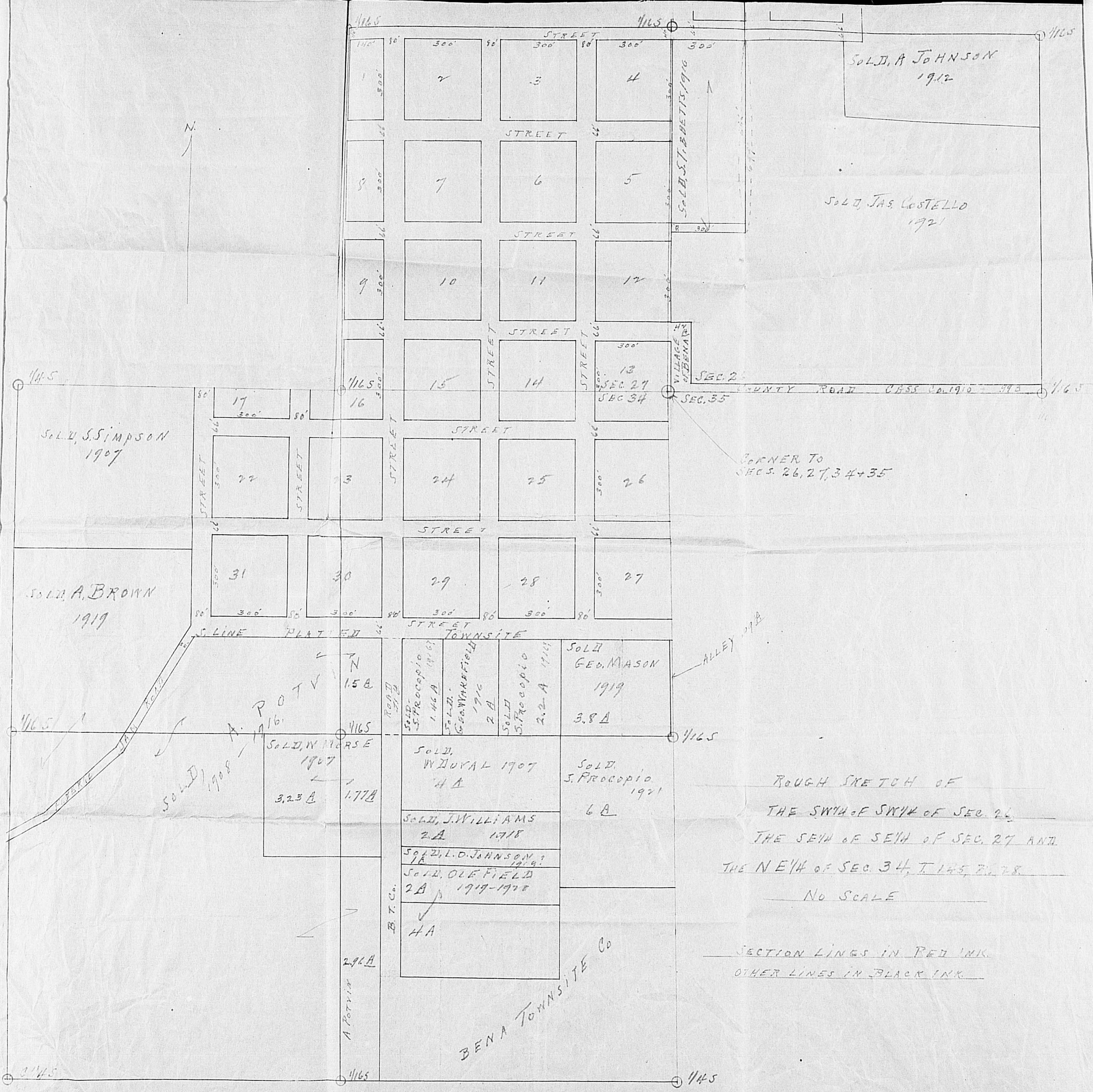












ROUGH SKETCH OF
