Extracts from Laws Relating to the Listing of Personal Property.

(Section Numbers Refer to Mason's Minnesota Statutes of 1927.)

Sec. 1974. PROPERTY SUBJECT TO TAXATION. All Real and Personal Property in this State, and all Personal property of persons residing therein, . . . is taxable, except such as is by law exempt from taxation.

WHEN LISTED AND ASSESSED. Sec. 1984. . . . Personal Property shall be listed and assessed annually with reference to its value on May 1, and, if acquired on that day, shall be listed by or for the person acquiring it, in the manner followed of full age and sound mind, being a resident of this state, shall list all his moneys, credits, stocks, bonds, notes, mortgages, real estate, and other property owned by him, in any other state or territory, money loaned or invested, annuities, franchises, royalties, and other personal property, and in the name of his principal, all moneys and other personal property inherited, loaned, or otherwise controlled by him, in any other state or territory, and all moneys deposited in any bank, company or corporation, and all moneys due from or owing by any person, firm or loaner person shall be listed by the proprietor, or by the person having such property in charge, or by the administrator.

Sec. 1989. By whom listed. Personal property shall be listed in the manner followed of full age and sound mind, being a resident of this state, shall list all his moneys, credits, stocks, bonds, notes, mortgages, real estate, and other property owned by him, in any other state or territory, money loaned or invested, annuities, franchises, royalties, and other personal property, and in the name of his principal, all moneys and other personal property inherited, loaned, or otherwise controlled by him, in any other state or territory, and all moneys deposited in any bank, company or corporation, and all moneys due from or owing by any person, firm or loaner person shall be listed by the proprietor, or by the person having such property in charge, or by the administrator.

Sec. 2000. Farm property of agriculturist. When the owner of a farm property, or of any other property, is an agriculturist, he shall not be liable for the listing of such property, but shall be liable for the listing of such property in the town or district where the same shall be listed, and assessed in the manner followed of full age and sound mind, being a resident of this state, shall list all his moneys, credits, stocks, bonds, notes, mortgages, real estate, and other property owned by him, in any other state or territory, money loaned or invested, annuities, franchises, royalties, and other personal property, and in the name of his principal, all moneys and other personal property inherited, loaned, or otherwise controlled by him, in any other state or territory, and all moneys deposited in any bank, company or corporation, and all moneys due from or owing by any person, firm or loaner person shall be listed by the proprietor, or by the person having such property in charge, or by the administrator.
