Extracts from Laws Relating to the Listing of Personal Property.

(Section Numbers Refer to Minnesota Statutes 1941)

Sec. 273.01. PROPERTY SUBJECT TO TAXATION. All real and personal property in this state, and all personal property of persons residing therein, and all taxable, except such as is by law exempt from taxation.

WHEN LISTED AND ASSESSED

Sec. 273.01. Personal property shall be listed and assessed annually with reference to its value on May 1, and if acquired on that day, shall be listed by or for the persons acquiring it.

Sec. 273.02. By whom listed. Personal property shall be listed in the manner following:

1. Every person of full age and sound mind, being a resident of this state, shall list all of his personal property.

2. If the owner of the property is a minor, child or insane person, all moneys and other personal property invested, loaned, or otherwise controlled by him as agent or attorney, etc.

3. The property of a minor, child or insane person shall be listed by his trustee, or the trustee of the estate of a deceased person, by the executor or administrator.

4. The property of a body politic or corporate, by the proper agent or officer thereof.

5. The property of a firm or company, by a partner or agent thereof, by such agent in the name of his principal, as merchandise.

Sec. 273.26. Farm property of non-resident. When the owner of real estate in this state is a non-resident, the farm, buildings, and other improvements thereon, shall be listed and assessed in the name of the owner, by the person in possession of such property.

Sec. 273.27. Corporations. Every corporation, partnership, firm, or other body politic or corporate, shall be listed and assessed in the name of the corporation, partnership, firm, or other body politic or corporate, by the proper agent or officer thereof.

Sec. 273.28. Merchants and manufacturers. The personal property of a merchant or manufacturer, shall be listed and assessed in the name of the merchant or manufacturer, by the proper agent or officer thereof.

Sec. 273.29. Estates of decedents. The personal property of a decedent, shall be listed and assessed in the name of the decedent, by the executor or administrator.

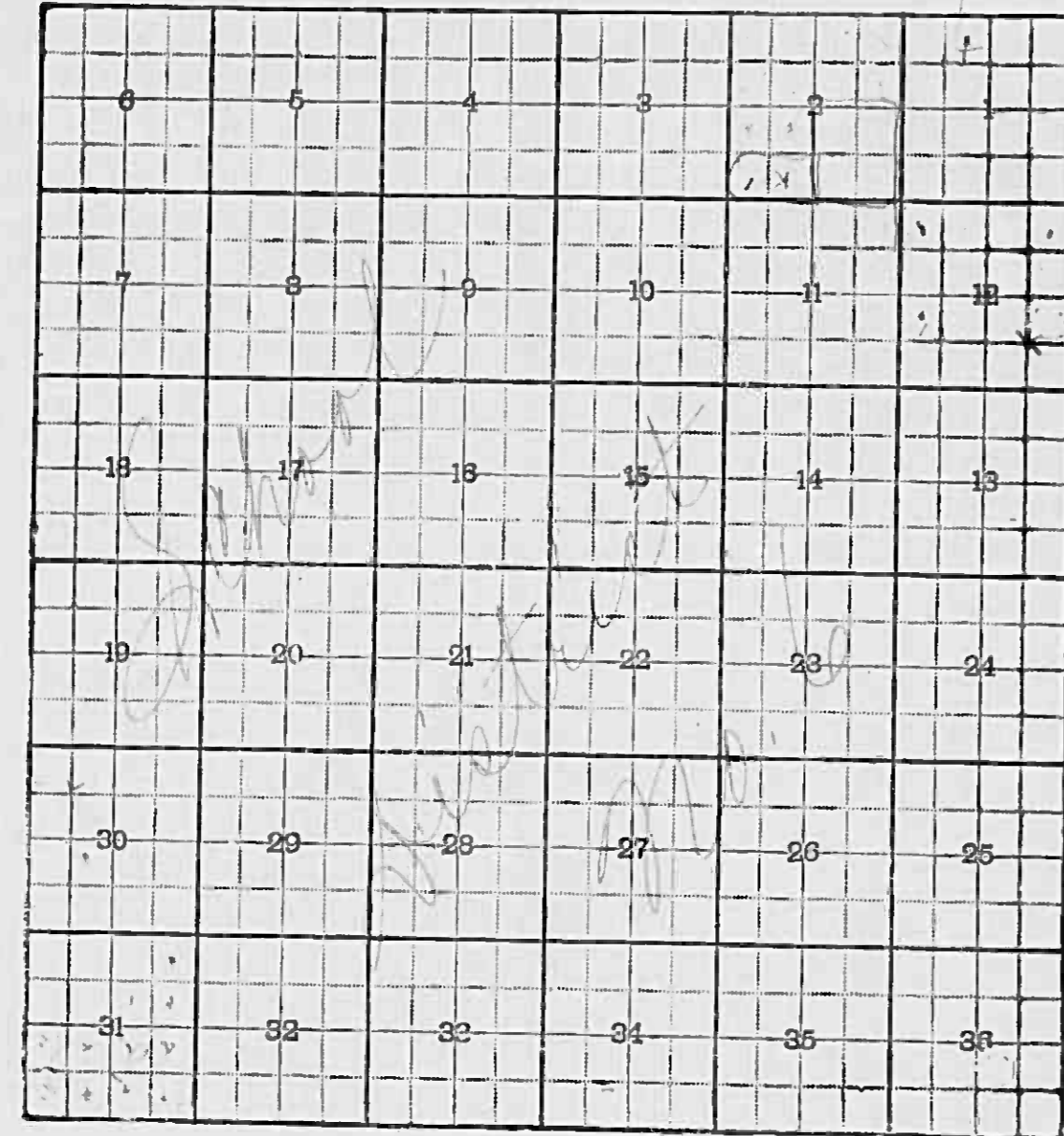
