Line 11: \$100 value entered here in error in copying values since Lot 7 was absorbed by Lot 6 and Lot 8 leaving one line less in 1957 tax list than in 1956 tax list. The \$100 value should have been entered against Lot 11 on Line 10. No correction of this error was made when it was discovered since the Treasurer had made a certificate in good faith that the tax was \$9.04 against Lot 11 and said tax was paid in good faith by the taxpayer on the basis of the certificate. \$67 valuation lost on Lot 11 for the year 1957 since \$33 of the \$100 value was collected.
