Extracts from Laws Relating to the Listing of Personal Property.

(Section Numbers Refer to General Statutes, 1923.)

Sec. 1974. PROPERTY SUBJECT TO TAXATION. All Real and Personal Property in this State, and all Personal Property of persons residing therein, ... is taxable, except such as is by law exempt from taxation.

WHEN LISTED AND ASSESSED.

Sec. 1984. ... Personal Property shall be listed and assessed annually with reference to its value on May 1, and, if not acquired on that day, shall be listed by or for the person acquiring it. Sec. 1989. ... Personal property shall be listed in the manner following: 1. Every person of full age and sound mind, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies or corporations...

Sec. 2017. Property moved between May and July. The owner of personal property, removing from one county, town, or district to another, shall file a statement with the assessor of the county into which the property is moved, stating the date of removal, the date of the removal, and the date of the removal...

Sec. 2022. Lists to be Verified. Every person required to list his personal property shall make out a list of the same, and shall submit the same to the assessor of the county, town, or district, who shall verify the same, and shall return the same to the assessor...

Sec. 2030. False statement regarding taxes. Every person who shall be liable for taxes on personal property, and who shall have been assessed for such taxes, and who shall have failed to pay the same...

Sec. 2036. Classification of Property. What personal property shall be assessed for taxation shall be classified as follows: Class 1. Live stock, whether valued or unvalued, shall constitute a class one...
