EXTRACTS FROM LAWS

(Section Numbers refer to Mason's Minn. Statutes 1927.)
Sec. 1974. Property subject to taxation--All real and personal property in the state, and all personal property of persons residing therein, is taxable, except such as is by law exempt from taxation.
WHEN LISTED AND ASSESSED
Sec. 1984. All real property subject to taxation shall be listed and assessed every even-numbered year with reference to its value on May 1 preceding the assessment, and all real property shall be listed and assessed annually with reference to its value on May 1, and, if acquired on that day, shall be listed by the person acquiring it.
RELATING TO LISTING OF PERSONAL PROPERTY
Sec. 1989. By whom listed. Personal property shall be listed in the name of the owner, agent, or trustee residing in the county in which the property is situated.
Sec. 1990. Property to be listed. Personal property shall be listed in the name of the owner, agent, or trustee residing in the county in which the property is situated.
Sec. 1991. Property to be listed. Personal property shall be listed in the name of the owner, agent, or trustee residing in the county in which the property is situated.
Sec. 1992. Lists to be verified. Every person who, in making any statement, oral or written, which is required or authorized by law to be made and delivered to the assessor, shall be held to be guilty of a gross misdemeanor, who shall wilfully make any statement as to any material matter which he knows to be false, shall be guilty of a gross misdemeanor, and shall be liable to a fine not exceeding \$100, or to imprisonment not exceeding one year, or to both such fine and imprisonment.
Sec. 1997. Assessor may enter dwelling etc. for valuation. The assessor shall have the right to enter any dwelling, building, or structure, and view the same, for the purpose of ascertaining the value thereof, and to take such measurements as may be necessary for that purpose, and to take such photographs as may be necessary for that purpose, and to take such other measures as may be necessary for that purpose, and to take such other measures as may be necessary for that purpose.
