Extracts from Laws, Relating to the Listing of Personal Property. (Section Numbers refer to Mason's Minnesota Statutes of 1927)

Sec. 1974. Property subject to taxation. All real and personal property in this state, and all personal property of persons residing therein in which, every such tax is to be levied and assessed in the manner following:

1. Every person of full age and sound mind, being a resident of this state, shall be liable for the taxation of his real and personal property, and of other real estate, and of other personal property, including franchises, franchises, royalties, and other personal property, in which he has an interest, in the same manner as if he were the owner thereof.

2. The property of a minor child or insane person shall be assessed by his guardian, or by the person having such property in charge.

3. The property of a person for whose benefit it is held in trust by the trustee, or by a corporation, shall be assessed in the hands of the trustee, or by the corporation, whose name is in the hands of the trustee, or by the corporation.
