Extracts from Laws Relating to the Listing of Personal Property.

(Section Numbers Refer to Minnesota Statutes of 1927.)

Sec. 1974. PROPERTY SUBJECT TO TAXATION. All Real and Personal Property in this State, and all Personal Property of every description, is taxable, except such as is by law exempt from taxation.

Sec. 1984. WHEN LISTED AND ASSESSED. Every piece of personal property owned and assessed annually with reference to its value on May 1, and if acquired on that day, shall be listed by or for the person acquiring it in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 1995. BY WHOM LISTED. Personal property shall be listed in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2005. MERCHANTS AND MANUFACTURERS. The personal property pertaining to the business of a merchant or of a manufacturer shall be listed by him or by his agent, or by the person in charge thereof, in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2015. PERSONS UNDER GUARDIANSHIP. The personal property of a person under guardianship shall be listed by the guardian, or by the person in charge thereof, in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2025. ELECTRIC LIGHT AND POWER COMPANIES. The personal property of an electric light and power company shall be listed by the company, or by the person in charge thereof, in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2035. PERSONS UNDER GUARDIANSHIP. The personal property of a person under guardianship shall be listed by the guardian, or by the person in charge thereof, in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2045. PERSONS UNDER GUARDIANSHIP. The personal property of a person under guardianship shall be listed by the guardian, or by the person in charge thereof, in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2055. PERSONS UNDER GUARDIANSHIP. The personal property of a person under guardianship shall be listed by the guardian, or by the person in charge thereof, in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2065. PERSONS UNDER GUARDIANSHIP. The personal property of a person under guardianship shall be listed by the guardian, or by the person in charge thereof, in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2002. LISTS TO BE VERIFIED. Every person required to list personal property owned by him on May 1 of the current year, shall verify the list by signing and swearing to the truth of the same, and shall deliver the same to the assessor, or to the person in charge thereof, in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2003. EXAMINATION UNDER OATH. Whenever the assessor shall be of the opinion that the person listing property for himself or for another person, or the person in charge thereof, has not made or will not make a true and correct list of the property, he may examine the person under oath in regard to the amount of the property he is listing, and the assessor shall be authorized by law to make a discovery under oath, in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2004. FALSE STATEMENT REGARDING TAXES. Every person who, in listing property for himself or for another person, or the person in charge thereof, makes or will make a false statement, or omits to make a true statement, or makes or will make a statement which he knows to be false, shall be guilty of a gross misdemeanor, in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2005. CLASSIFICATION OF PROPERTY. All real and personal property shall be classified into classes, in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2006. VALUE OF PROPERTY. The value of all property shall be determined in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2007. VALUE OF PROPERTY. The value of all property shall be determined in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2008. VALUE OF PROPERTY. The value of all property shall be determined in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2017. VALUE OF PROPERTY. The value of all property shall be determined in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Sec. 2018. VALUE OF PROPERTY. The value of all property shall be determined in the manner following: All goods and chattels, being a resident of this state, shall list all his moneys, credits, bonds, shares of stock of joint stock or other companies, or corporations (when the stock is owned in his own name), money loaned or invested, annuities, franchises, royalties, and other personal property.

Duluth Cass

Section 1986, Mason's Minnesota Statutes, 1927. The county auditor shall annually provide the necessary assessment books and blanks at the expense of the county, for and to correspond with each assessment district. He shall make out, in the real property assessment book, complete lists of all lands or lots subject to taxation, showing the names of the owners, if he knows, and, if unknown, so stated opposite each tract or lot, the number of acres, and the lots or parts of lots, or blocks included in each description of property. The list of real property becoming subject to assessment and taxation every odd numbered year may be appended to the personal property assessment book. The assessment books and blanks shall be in readiness for delivery to the assessors or before the assessors shall receive their appointments. The county auditor on a day to be fixed by the Minnesota Tax Commission for the purpose of receiving instructions as to their duties under the laws of the state. Each assessor attending such meeting shall receive a compensation for such service the sum of four dollars per day for each day necessarily traveled in going from his home to and returning from the place at the rate of five cents per mile for each mile necessarily traveled in going from the county treasury upon the warrant of the county seat to be computed by the usually traveled route and paid out of the county treasury upon the warrant of the county auditor.
