Extracts from Laws Relating to the Listing of Personal Property.

(Sections Numbers Refer to General Statutes, 1923.)

Sec. 574. PROPERTY SUBJECT TO TAXATION. All Real and Personal Property in this State, and all Personal Property of persons residing therein, *** is taxable, except such as is by law exempt from taxation.

Section 1886. General Statutes of Minnesota 1923. The county auditor shall annually provide the necessary assessment books and city assessment book, complete lists of all lands or lots subject to taxation, showing the names of the owners, if so listed, in each description of the property. The list of real property becoming subject to assessment and taxation every odd numbered year shall be appended to the personal property assessment book. The assessment books and blanks shall be in readiness for delivery to the assessors on or before the third Monday in APRIL of each year.
