Extracts from Laws Relating to the Listing of Personal Property. (Section Numbers Refer to Minnesota Statutes 1953)

Sec. 272.01. PROPERTY SUBJECT TO TAXATION. All real and personal property in this state, and all personal property of persons residing therein, is taxable, except such as is by law exempt from taxation.

WHEN LISTED AND ASSESSED

Sec. 273.01. Personal Property shall be listed and assessed annually with reference to the first day of May, and shall be listed by the assessor on that day, and shall be listed by or for the person acquiring it.

Sec. 273.02. Personal Property shall be listed in the manner following:

- 1. Every person of full age and sound mind, being a resident of this state, shall list all of his personal property.
2. He shall also list separately, and in the name of the executor, administrator or guardian, all real estate, real estate interests, and all personal property controlled by him as agent or attorney.
3. The property of a minor, child or insane person shall be listed by his guardian or by his person in charge, and shall be assessed by the trustee of the estate of a deceased person, by the executor or administrator.
4. Real estate interests, real estate, and all personal property of a corporation whose assets are in the hands of a receiver, shall be listed and assessed by the proper agent or officer thereof.
5. The property of a firm or company, by a partner or agent thereof.
6. The property of a body politic or corporate, by the proper agent or officer thereof.
7. The property of a firm or company, by a partner or agent thereof.
8. The property of manufacturers and others in the hands of an assignee, shall be listed and assessed by the assignee.
9. The property of a firm or company, by a partner or agent thereof.
10. The property of a firm or company, by a partner or agent thereof.

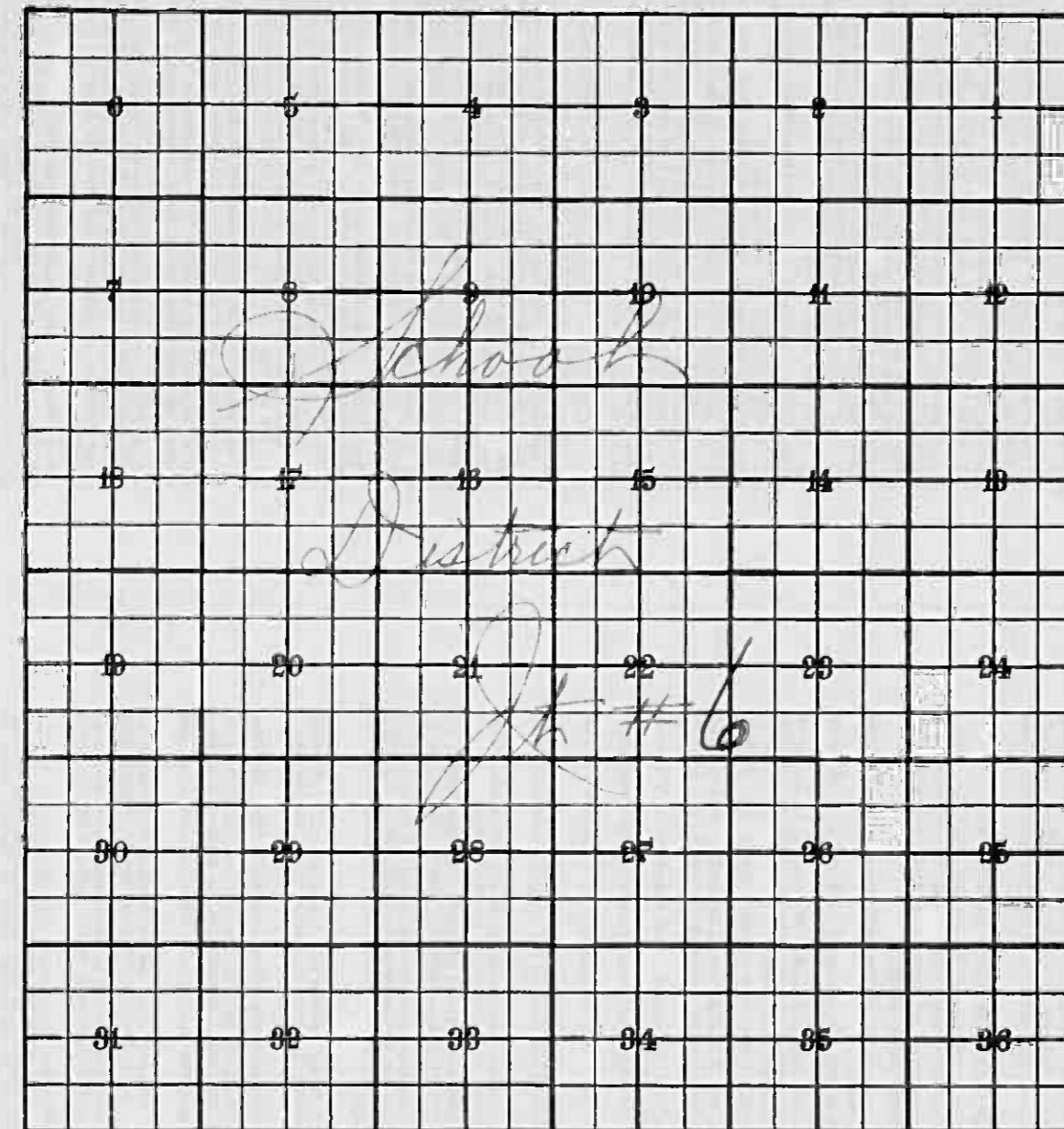
