

That part of the Southwest Quarter of the Northwest Quarter, Section 2, Township 141 North, Range 26 West, Cass County, Minnesota described as follows: Commencing at the Southwest corner of said Southwest Quarter of the Northwest Quarter; thence on an assumed bearing of North along the west line thereof a distance of 657.45 feet to the point of beginning of the tract to be herein described; thence continuing on a bearing of North along said west line 325.80 feet to the north line of the south 15 acres of the West Half of said Southwest Quarter of the Northwest Quarter; thence South 88 degrees 08 minutes 42 seconds East along said north line 665.18 feet to the east line of said West Half of the Southwest Quarter of the Northwest Quarter; thence South 00 degrees 03 minutes 07 seconds West along said east line 281.35 feet to the intersection with a line bearing North 88 degrees 01 minutes 32 seconds East from the point of beginning; thence South 88 degrees 01 minutes 32 seconds West 664.97 feet to the point of beginning.

That part of the Southwest Quarter of the Northwest Quarter, Section 2, Township 141 North, Range 26 West, Cass County, Minnesota described as follows: Commencing at the Southwest corner of said Southwest Quarter of the Northwest Quarter; thence on an assumed bearing of North along the west line thereof a distance of 474.90 feet to the point of beginning of the tract to be herein described; thence continue on a bearing of North along said west line 182.55 feet; thence North 88 degrees 01 minutes 32 seconds East 664.97 feet to the east line of the West Half of said Southwest Quarter of the Northwest Quarter; thence South 00 degrees 03 minutes 07 seconds West, along said east line, 219.99 feet to the intersection with a line bearing South 88 degrees 44 minutes 51 seconds East from the point of beginning; thence North 88 degrees 44 minutes 51 seconds West 664.54 feet to the point of beginning.




