That part of the Northwest Quarter of the Northwest Quarter, Section 5, Township 137, Range 29, Cass County, Minnesota described as follows: Commencing at the Northwest corner of said Section 5 a distance of 500.00 feet; thence Southerly at right angles to the North line of said Section 5 a distance of 250.00 feet to a point; thence in an Easterly direction parallel to the North line of said Section 5 a distance of 130.00 feet to a point, the point of beginning of the tract to be herein described; thence Easterly, parallel with said North line of Section 5 a distance of 130.00 feet; thence Northerly at right angles to the North line of said Section 5 a distance of 250 feet, more or less, to the North line of said Section 5; thence Easterly along the North line of said Section 5 a distance of 199.96 feet to the east line of the west 829.89 feet of said Section 5; thence Southerly, along said east line, 829.89 feet; thence Westerly, parallel with the North line of said Section 5, a distance of 429.96 feet to the east line of the west 400.00 feet of said Section 5; thence Northerly, along said east line, a distance of 351.95 feet to the south line of the north 330.00 feet of Section 5; thence Easterly, along said South line, a distance of 235.75 feet more or less, to a point of intersection with a line running through said point of beginning at right angles to said North line of said Section 5; thence Northerly along said line running through said point of beginning, 80 feet, more or less, to the point of beginning. 
