



# CERTIFICATE OF SURVEY

Legal Descriptions per document No. 308089

**Tract A**

That part of Lot Eight (8), Section (8), Township One Hundred Forty (140), Range Twenty-nine (29), Cass County, Minnesota described as follows: Commencing at the Southeast corner of what was formerly Lot 149 of the Plat of Interlachen Lodge before a portion of said Plat was vacated; thence northeasterly along the westerly side of Broadway Street in said Plat a distance of approximately 216 feet to what was formerly the Southeast corner of Lot 153 of said Plat; thence westerly approximately 400 feet to what was formerly the Northwest corner of Lot 153 of said Plat; thence southerly along the lake shore of Kid Lake approximately 260 feet to what was formerly the Southwest corner of Lot 149 of said Plat; thence easterly along the North side of South Street of said Plat approximately 370 feet to the place of beginning, excepting therefrom the following described Tract B.


**Tract B**

That part of Lot Eight (8), Section (8), Township One Hundred Forty (140), Range Twenty-nine (29), Cass County, Minnesota described as follows: Commencing at the Southeast corner of what was formerly known as Lot 152 of the Plat of Interlachen Lodge before a portion of said Plat was vacated; thence Northeasterly along the western side of Broadway Street in said Plat, 54 feet to what was formerly the Southeast corner of Lot 153 of said Plat; thence westerly 400 feet to what was formerly the Northwest corner of said Lot 153 of said Plat; thence southerly along the Lake shore of Kid Lake approximately 100 feet to what was formerly the Southwest corner of Lot 152 of said Plat; thence easterly along the South line of said Lot 152 to the place of beginning.
