
# CERTIFICATE OF SURVEY

### DESCRIPTION:

TRACT "A"

Lot 1, Block 1 of TAYLOR TIMBER, according to the recorded plat thereof on file in the office of the County Recorder, Cass County, Minnesota.

#### nd

Those parts of Lots 2, 3, and 4, Block 1 of TAYLOR TIMBER, according to the recorded plat thereof on file in the office of the County Recorder, Cass County, Minnesota, which lies easterly of the following described line:

Commencing at the northwest corner of said Lot 2; thence on an assumed bearing of South 89 degrees 56 minutes 38 seconds East, along the north line of said Lot 2, a distance of 345.94 feet to the point of beginning of the line to be described; thence South 34 degrees 43 minutes 23 seconds East a distance of 213.06 feet to the south line of said Lot 2, said point being 522.49 feet along said south line east of the southwest corner of said Lot 2; thence South 05 degrees 59 minutes 00 seconds East a distance of 175.98 feet to the south line of said Lot 3, said point being 502.14 feet along said south line east of the southwest corner of said Lot 3; thence South 19 degrees 51 minutes 15 seconds East a distance of 243.64 feet to the south line of said Lot 4, said point being 534.66 feet along said south line east of southwest corner of said Lot 4 and said line there terminating.

Said parcel of land contains 9.776 acres of land, more or less, and is subject to existing easements of record.

#### TRACT "B"

That part of Lot 2, Block 1 of TAYLOR TIMBER, according to the recorded plat thereof on file in the office of the County Recorder, Cass County, Minnesota, which lies westerly of the following described line:

Commencing at the northwest corner of said Lot 2; thence on an assumed bearing of South 89 degrees 56 minutes 38 seconds East, along the north line of said Lot 2, a distance of 345.94 feet to the point of beginning of the line to be described; thence South 34 degrees 43 minutes 23 seconds East a distance of 213.06 feet to the south line of said Lot 2, said point being 522.49 feet along said south line east of the southwest corner of said Lot 2 and said line there terminating.

Said parcel of land contains 1.745 acres of land, more or less, and is subject to existing easements of record.

#### TRACT "C"

That part of Lot 3, Block 1 of TAYLOR TIMBER, according to the recorded plat thereof on file in the office of the County Recorder, Cass County, Minnesota, which lies westerly of the following described line:

Commencing at the northwest corner of said Lot 3; thence on an assumed bearing of South 89 degrees 56 minutes 38 seconds East, along the north line of said Lot 3, a distance of 522.49 feet to the point of beginning of the line to be described; South 05 degrees 59 minutes 00 seconds East a distance of 175.98 feet to the south line of said Lot 3, said point being 502.14 feet along said south line east of the southwest corner of said Lot 3 and said line there terminating.

Said parcel of land contains 2.058 acres of land, more or less, and is subject to existing easements of record.

#### TRACT "D"

That part of Lot 4, Block 1 of TAYLOR TIMBER, according to the recorded plat thereof on file in the office of the County Recorder, Cass County, Minnesota, which lies westerly of the following described line:

Commencing at the northwest corner of said Lot 4; thence on an assumed bearing of South 89 degrees 56 minutes 38 seconds East, along the north line of said Lot 4, a distance of 502.14 feet to the point of beginning of the line to be described; thence South 19 degrees 51 minutes 15 seconds East a distance of 243.64 feet to the south line of said Lot 4, said point being 534.66 feet along said south line east of southwest corner of said Lot 4 and said line there terminating.

Said parcel of land contains 2.713 acres of land, more or less, and is subject to existing easements of record.
