



### DESCRIPTION PROVIDED

The Southwest One-quarter of the Southeast One-Quarter (SW ¼ of SE ¼) of Section One (1), Township One Hundred and Forty (140), Range Twenty-nine (29), together with and subject to an easement for a roadway across said Section One (1), for the benefit of the above described property and other lands.

An easement for ingress, egress, and utility purposes 66.00 feet in width over, under, and across those parts of the Southwest Quarter of the Southeast Quarter, Section 1, and Government Lot 1, Section 12, all in Township 140 North, Range 29 West, Cass County, Minnesota, the centerline of which is described as follows: Commencing at the North Quarter corner of said Section 12; thence South 4 degrees 59 minutes 44 seconds East, assumed bearing along the north-south quarter line of said Section 12 a distance of 575.03 feet to the point of beginning of the centerline to be herein described; thence North 55 degrees 25 minutes 31 seconds East 126.86 feet; thence easterly 190.13 feet along a tangential curve concave to the south, having a radius of 300.00 feet and a central angle of 36 degrees 18 minutes 46 seconds; thence South 88 degrees 15 minutes 43 seconds East, tangent to said curve 67.37 feet; thence easterly 114.32 feet along a tangential curve concave to the north, having a radius of 283.00 feet and a central angle of 23 degrees 08 minutes 39 seconds; thence North 68 degrees 35 minutes 38 seconds East, tangent to last said curve 127.04 feet; thence North 43 degrees 35 minutes 47 seconds East 239.79 feet; thence North 21 degrees 03 minutes 57 seconds East 553.15 feet; thence northerly 176.03 feet along a tangential curve concave to the west, having a radius of 750.00 feet and a central angle of 13 degrees 26 minutes 52 seconds; thence North 7 degrees 37 minutes 05 seconds East, tangent to last said curve 182.34 feet; thence northerly 201.11 feet along a tangential curve concave to the west, having a radius of 1000.00 feet and a central angle of 11 degrees 31 minutes 21 seconds; thence North 3 degrees 54 minutes 16 seconds West, tangent to last said curve 160.28 feet; thence northeasterly 175.76 feet along a tangential curve concave to the southeast, having a radius of 150.00 feet and a central angle of 67 degrees 08 minutes 05 seconds; thence North 63 degrees 13 minutes 49 seconds East, tangent to last said curve 46.83 feet; thence northeasterly 82.71 feet along a tangential curve concave to the southeast, having a radius of 300.00 feet and a central angle of 15 degrees 47 minutes 47 seconds to the east line of said Southwest Quarter of the Southeast Quarter of Section 1 and said centerline there terminating. The sidelines of said easement are prolonged or shortened to terminate on said north-south quarter line of Section 12 and on the east line of said Southwest Quarter of the Southeast Quarter of Section 1.

The centerline as described above is based on the existing centerline location of Timber Drive NW as of the date of this survey.

### NORTH EASEMENT

An easement for ingress, egress, and utility purposes over, under, and across that part of the Southwest Quarter of the Southeast Quarter, Section 1, Township 140 North, Range 29 West, Cass County, Minnesota, the centerline of which is described as follows: Commencing at the northeast corner of said Southwest Quarter of the Southeast Quarter; thence South 88 degrees 14 minutes 28 seconds West, assumed bearing along the north line thereof 691.55 feet to the east line of the West 573.27 feet of said Southwest Quarter of the Southeast Quarter; thence South 0 degrees 13 minutes 25 seconds East along said east line 200.07 feet to the point of beginning of the centerline of a 66.00 foot wide easement to be herein described; thence North 62 degrees 51 minutes 45 seconds East 74.00 feet to the point of termination of said 66.00 foot wide easement and the point of beginning of the centerline of a 33.00 foot wide easement to be herein described; thence continuing North 62 degrees 51 minutes 45 seconds East 132.57 feet; thence easterly 307.05 feet along a tangential curve concave to the south, having a radius of 300.00 feet and a central angle of 58 degrees 38 minutes 32 seconds; thence South 58 degrees 29 minutes 43 seconds East, tangent to said curve 110.97 feet to the centerline of Timber Drive NW and said centerline of a 33.00 foot wide easement there terminating. The sidelines of said 66.00 foot wide easement are prolonged or shortened to terminate on said east line of the West 573.27 feet.
