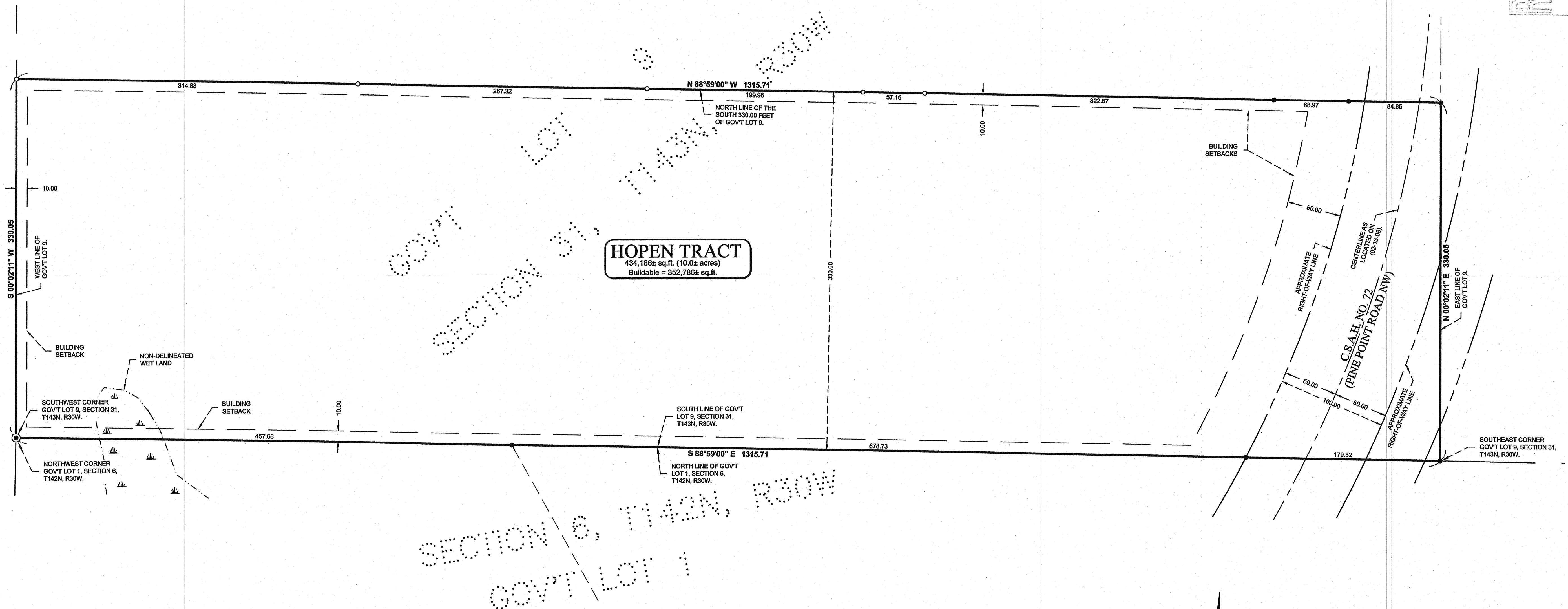

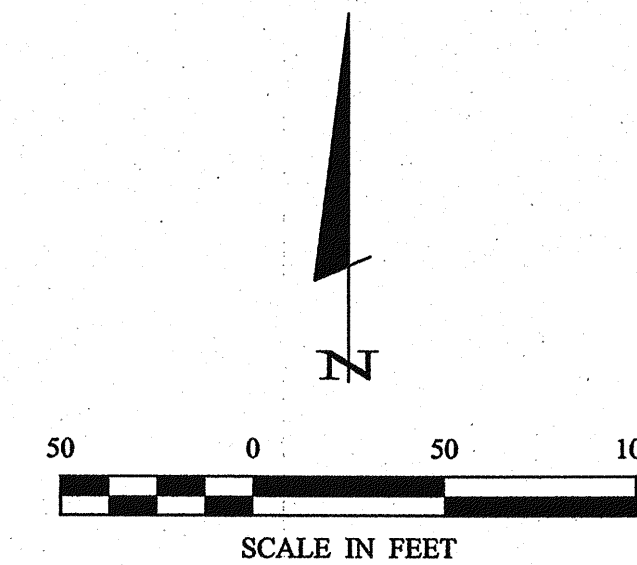

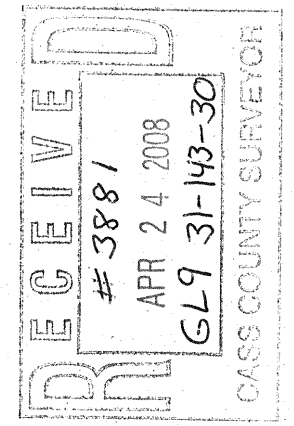
1. There may be more physical above ground features, or wet land information than what is shown on this Certificate of Survey.
