
### DESCRIPTION - (PROPOSED INGRESS & EGRESS EASEMENT)

A 40.00 foot wide perpetual easement for ingress and egress purposes over and across Government Lot 5, Section 2, Township 140, Range 28, Cass County, Minnesota. The centerline of said easement is described as follows:

Commencing at the northwest corner of the South 281.00 feet of the East 467.76 feet of said Government Lot 5; thence South 00 degrees 12 minutes 47 seconds East a distance of 20.00 feet to the point of beginning of the centerline to be described; thence South 89 degrees 47 minutes 13 seconds West a distance of 19.50 feet; thence South 42 degrees 42 minutes 47 seconds East a distance of 164.74 feet, and said centerline there terminating.


The sidelines of said easement are to be prolonged or shortened to terminate at the centerline of Sioux Camp Road NW.
